Coverage may be subject to a minimum participation requirement at the Local Union level and if the minimum is not met, coverage may not be issued even though an enrollment form has been completed. An effective date is subject to eligibility requirement, satisfaction of service waiting period (if applicable) and payment of first premium when due. An effective date may be deferred for a member not actively at work.

- If payroll deduction of premium begins prior to processing of the enrollment form, it does not mean coverage is in effect. Premiums paid for coverage not issued will be returned.
- Benefits may not be payable for a disability due to a pre-existing condition, should the insured become disabled due to such pre-existing condition within the first 12 months of coverage. A pre-existing condition is any condition (whether diagnosed or not) for which an insured sought treatment, advice, care or services from a doctor, or for which he/she took prescription drugs or medicines within 12 months before the individual effective date of coverage.
